**2024-2025 Winter Season**

Big Sky Resort proudly continues the M-BAR-T Program offering reduced rate season passes, to:

- Inspire young people to achieve academic growth and excellence
- Provide outdoor recreational opportunities to the area’s youth
- Promote skiing/riding as a lifelong activity to be shared with the family
- Allow young people to experience the beauty, freedom and physical challenge of snow sports

There are three types of M-BAR-T passes available. Eligibility, qualifications, and rules are applicable to all types.

**AGES FOR DOUBLE BLACK ARE AS OF DECEMBER 1<sup>st</sup>, 2024**

- **Double Black Pass:** 25 Ski Rides and 10 Scenic Rides of Tram Access, No Blackout Dates. Teen (13-17) \$1,020 + tax\*, Junior (7-12) \$700 + tax\*
- **Black Pass:** No Tram Access, No Blackout Dates. \$500 + tax\*
- **Blue Pass:** No Tram Access, No Saturdays, Blackout Dates (12-26 to 12-31, 1-18 & 19, 2-15 & 16). \$300 + tax\*

**Eligibility – Public and Private School Students**

M-BAR-T season passes are available to 1<sup>st</sup> through 12<sup>th</sup> grade students in Gallatin, Madison, Beaverhead, Park, and Sweet Grass counties. Only students attending a public or private **participating** school are eligible to receive an M-BAR-T pass.

**Qualifying Criteria – Public and Private School Students**

- Achieve a 3.0 GPA or higher for the 1<sup>st</sup> applicable grading period of the 2024-25 school year.

The grading period is different for each participating school and is determined by Big Sky Resort and the participating school. Contact your individual school for the agreed upon dates. **No refunds are provided to any student, which for any reason, lose their pass privileges. This applies to ALL types of passes – no exceptions.**

**Grade Verification Methods – Public and Private School Students**

There are two verification methods available. Only one method of verification will be utilized by each individual school. Each individual school determines their preferred method of verification.

- **Method 1:** School provides to Big Sky Resort a **list of “Eligible Students”** that meet the 3.0 GPA grade requirements at the end of the pre-determined 1<sup>st</sup> grading period.
- **Method 2:** School provides to individual students a **“Letter of Eligibility” on school letterhead** indicating the student met the 3.0 GPA requirements at the end of the pre-determined 1<sup>st</sup> grading period.

**HOW TO APPLY**

- 1) Parent and Student must each read, sign and date this informational document.
- 2) Determine your school’s grade verification method. Confirm with your school that the student’s name is on the list of “Eligible Students” sent to Big Sky Resort – or – obtain a “Letter of Eligibility” on school letterhead. Original signed letters only – no copies will be accepted.
- 3) Parent and Student must complete, sign and date the 2024-25 M-BAR-T season pass agreement (also in this form).
- 4) Submit your informational document, season pass agreement, original Letter of Eligibility (if applicable), and payment form to the Ticket Windows in the Snowcrest Building at Mountain Village, Basecamp, or the Madison Base Area Ticket Office (when open). **Applications must be submitted in person – no exceptions.**

**A. ACKNOWLEDGEMENT OF RISKS:** I acknowledge that my presence at or use of ski areas, equipment, facilities and premises owned or operated by Boyne USA Inc. and its ski area operators (hereinafter "Facilities"), including but not limited to skiing, snowboarding, ski biking, Sno Go riding, the use of aerial and surface lifts, participation in ski or snowboard lessons, clinics and programs, participation in competitions and events and other winter sports and activities (singularly, "Activity," or plurally, "Activities"), involve risks which may be HAZARDOUS to skiers, snowboarders and other participants. I agree to ski, snowboard or otherwise use the Facilities and participate in the Activities only within the limits of my ability and I agree to familiarize myself with and follow "Your Responsibility Code." I understand that falls and injuries are a common occurrence. I understand I must keep deliberate and conscious control of my body, both on the ground and in the air, while properly using my equipment in variable weather and conditions. I understand my safety is directly affected by my judgment in the severe elements of rough, mountainous terrain. I understand my participation in skiing, riding, other snow sports, and the use of passenger tramways and lifts involve inherent risks which are dangers and conditions that are an integral part of the activity, as well as other known and unknown risks which include but are not limited to: risks related to loading, riding and unloading lifts; falling out of lifts; terrain selection by instructors; existing and changing weather conditions; existing and changing snow conditions such as ice, hardpack, powder, slush, crust, machine-made snow; deep snow conditions such as tree wells, snow immersion, slides and avalanches; surface or subsurface conditions such as dirt, grass, bare spots, rocks, cliffs, streams, forest growth and debris, stumps, falling or downed trees and limbs, and other natural objects; collisions with or falls resulting from such natural objects; falls caused by or collisions with lift towers, lights, poles, signs, posts, fences, mazes, enclosures, hydrants, pipes, snowmaking and snow-grooming equipment, trail maintenance vehicles and snowmobiles which may be operating at any time, other man-made structures or objects and their components; variations in visibility, steepness or terrain, whether natural or as a result of slope design, including but not limited to freestyle terrain, freestyle features, jumps, roads, catwalks, water bars, snowmaking whales or other terrain modifications; snowmaking or snow-grooming operations;

the presence of and collisions with other skiers, snowboarders and spectators; the failure of others to participate safely or within their own abilities; slips, trips and falls due to variable, uneven, wet, snowy, icy, and/or damaged condition of grounds and facilities including but not limited to buildings, structures, lifts, entries, exits, walkways, parking lots, restaurants, lodging facilities, children's facilities, restrooms, locker rooms, trails, slopes and base areas; encounters with wild or domestic animals. **I AGREE FREELY AND VOLUNTARILY TO ASSUME ALL RISKS** including the risk of personal injury, illness, death or property damage associated with use of the Facilities. Such risks also include the risk of catching a communicable disease. In addition to and without limiting the above, I also acknowledge acceptance of any inherent or other risk described in any Ski Area Statute, Rule or Regulation in the jurisdiction in which the Facilities are located.

**B. LIABILITY RELEASE AND INDEMNITY AGREEMENT:** In consideration of being permitted to use the Facilities and/or participate in any of the Activities, **I AGREE** on behalf of myself, my estate, my assigns and if applicable, my minor children or wards, **TO RELEASE, DEFEND, INDEMNIFY AND HOLD HARMLESS THE RELEASEES FROM ANY AND ALL LEGAL LIABILITY** for personal injury, illness, death, or property damage sustained in connection with my and, if applicable, my minor children or wards', use of the RELEASEES' Facilities and/or participation in the any of the Activities, for any reason and under all circumstances, incurred at any time including any prior ski season. This Liability Release Agreement **INCLUDES BUT IS NOT LIMITED TO CLAIMS BASED ON ALLEGED NEGLIGENCE OR BREACH OF WARRANTY BY THE RELEASEES.**

**C. AGREEMENT NOT TO SUE AND FORUM SELECTION:** I agree not to sue the RELEASEES on my own behalf, and if applicable, on behalf of my estate, executor, administrator or representatives, my minor children or wards, for any claims of personal injury, illness, death or property damage which may occur from my or their use of the Facilities and/or participation in any of the Activities, **INCLUDING ALL CLAIMS BASED ON THE ALLEGED NEGLIGENCE OF RELEASEES.** Should any claim or action be asserted in contravention of this Agreement, I or my successor(s) shall indemnify and be liable for all expenses, **INCLUDING LEGAL FEES INCURRED BY RELEASEES.** I agree that this entire Agreement shall be governed by the laws of the State or Province where the incident occurred, as broadly as permitted by law, and that exclusive jurisdiction and venue for any legal action shall be in the State Court of the County where the incident occurred or the Federal District Court closest to the County where the incident occurred, or in the courts of the Province where the incident occurred. If any part of this Agreement is determined to be unenforceable, all other parts shall still be given full force and effect.

**Applicable to participants in ski and snowboard lessons:** I understand, accept and agree that if I and/or my minor child(ren) or ward(s), if applicable, participate in ski and snowboard lessons at a Facility that:

- a) I am responsible for disclosing to Facility staff any pre-existing medical condition that may affect me and/or their ability to participate in the Activities;
- b) I and/or they have the sufficient mental, emotional and physical stamina to participate in the Activities;
- c) I and/or they have the responsibility to follow the instructions of Facility staff;
- d) I and/or they have the responsibility to obey all signs, markings and warnings posted at the Facility, and to comply with Facility policies, and act in a safe manner;
- e) I and/or they may be required to wear a protective helmet;
- f) I and/or they may have to ride a ski lift with an adult or child who is not an instructor or a lesson participant;
- g) Facility staff cannot at all times maintain close enough visibility of or proximity to intervene, for any reasons including when using ski lifts or skiing or snowboarding.

**Applicable to participants in competitions and events:** I understand, accept, and agree that if I and/or my minor child(ren) or ward(s), if applicable, participate in competitions or events, that I and/or they:

- a) assume all dangers and risks associated with the competition or event and training course(s) including their features, layout, location, steepness, length, obstacles, and difficulty level; and
- b) I and/or they are solely responsible for inspecting the features, layout and other aspects of the event premises, competition course and training course(s) prior to use and determining in our sole discretion whether we are comfortable with and fit for participating in the event or competition.

**Applicable to Volunteers:** I understand, accept, and agree that if I and/or my minor child(ren) or ward(s), if applicable, volunteer to assist with the preparation, administration, management or governance of an Activity, event, or competition that:

- a) I and/or they are not an employee of the Facility, regardless of any non-cash remuneration for time and services which we may receive;
- b) **I and/or they are not covered by Workers' Compensation** nor entitled to any benefits under Workers' Compensation law, except for those jurisdictions in which I and/or they would be covered as a matter of law; and
- c) I and/or they are hereby advised to obtain our own medical insurance coverage for our volunteer position(s).

**D. PARENT/GUARDIAN RELEASE, AUTHORIZATION AND INDEMNIFICATION OF RELEASEES:** If applicable, as Parent or duly authorized Guardian for the minor(s) named below, I verify that I have authority to enter into this Agreement on behalf of my minor child(ren) or ward(s). I have read, understand and agree that my minor child(ren) and anyone acting on their behalf, including me, are bound by the terms of this Acknowledgement of Risks and Liability Release Agreement (hereafter "Agreement"). Furthermore, if any claim or action including any claim alleging **NEGLIGENCE** is brought by my minor child(ren) or ward(s), or anyone claiming to act on their behalf, against any RELEASEES, **I AGREE TO RELEASE, DEFEND, INDEMNIFY AND HOLD HARMLESS THE RELEASEES** for any and all expenses incurred by RELEASEES in defending and/or satisfying any judgment for such claim, **INCLUDING LEGAL FEES**. If I am not the parent or guardian of the minor child(ren) or ward(s), I nevertheless agree to release, defend, indemnify and hold harmless the RELEASEES. I also agree that if I have signed this Agreement on behalf of any other adult who refuses to accept and contravenes the terms of this Agreement by bringing a claim or action against the RELEASEES, including any claim alleging **NEGLIGENCE**, I will personally **DEFEND, INDEMNIFY AND HOLD HARMLESS RELEASEES** for any and all expenses incurred by the RELEASEES in defending and/or satisfying any judgment from such claim, including legal fees.

**E. LIABILITY RELEASE DURATION AND REVOCATION:** I agree that this Agreement shall apply to all uses of the RELEASEES' Facilities and all participation in any Activity or Activities regardless of the type or duration of the pass that is purchased or otherwise used to access the Facilities, whether as a single day lift pass, multi-day pass, season pass or any other type of pass which grants access to the lifts and Facilities. I understand and agree that this **LIABILITY RELEASE** will remain in effect and apply for every day that participant engages in skiing, snowboarding or other winter sports or recreation at any Boyne Facility or Resort, without executing an additional Liability Release Agreement for each day, season, or year, until a new Liability Release Agreement is executed (or this Liability Release Agreement is revoked by me in writing and that writing is accepted in writing, signed by the resort's authorized representative). A separate Liability Release Agreement may be required for equipment rental, lessons and other activities available at Facilities.

**F. BY MY SIGNATURE BELOW,** I understand that permission to use RELEASEES' premises and facilities and/or participate in any of the Activities is being given to the undersigned participant in exchange for the execution of this Liability Release Agreement. I have read the above paragraphs and fully understand them. I understand that this is a **LIABILITY RELEASE** that will legally prevent me or any other person from filing suit or making any other claims for damages in the event of personal injury, illness, death or property damage. I freely and voluntarily enter into this Agreement. I have made no misrepresentations to the RELEASEES in this purchase process. I intend this document to be interpreted as broadly as permissible by law and understand that it is not intended to assert any claims or defenses prohibited by law.

**Applicable to skiers and riders at Big Sky Resort LLC:** By signing this document you may be waiving your legal right to a jury trial to hold the provider legally responsible for any injuries or damages resulting from risks inherent in the sport or recreational opportunity or for any injuries or damages you may suffer due to the provider's ordinary negligence that are the result of the provider's failure to exercise reasonable care.

**Applicable to Big Sky Lone Peak Tram Terrain Access:** I understand that skiing off the Lone Peak Tram including Big Couloir, North Summit Snowfield, and triple black diamond terrain, presents extreme risks not present at most other ski areas. I understand that all terrain off the Lone Peak Tram is extremely steep and rocky and that if I fall, it may not be possible to self-arrest or stop sliding, and that I may slide over rocks, cliffs, and other debris and may suffer serious injury or death. I understand that skiing all terrain off Lone Peak terrain is my choice and that I can avoid these extraordinary risks by choosing not to ski this terrain.

**Applicable Ski Lifts, Inc. dba Summit at Snoqualmie Back Bowls Access:** By signing this document you acknowledge that the Alpentel **BACK BOWLS** is limited access, expert only, gated terrain and such access requires your agreement to an additional **BACK BOWLS** Release of Liability. You understand and agree that without your signature on the **BACK BOWLS Release of Liability**, you are not authorized to and must not enter **BACK BOWLS** terrain.

**BY MY SIGNATURE BELOW, I CERTIFY THAT:**

- 1. I AM AN ADULT PARTICIPANT, AT LEAST 18 YEARS OF AGE; OR**
- 2. I AM THE PARENT, LEGAL GUARDIAN OR OTHERWISE LEGALLY AUTHORIZED TO ENTER INTO THIS AGREEMENT ON BEHALF OF THE MINOR(S), AND I AGREE TO BE BOUND BY THIS LIABILITY RELEASE AGREEMENT ON THEIR BEHALF; OR**

# Terms and Conditions for Big Sky Resort Lift Tickets and Season Passes, Mountain Sports Lessons, Ski and Snowboard Rentals, Activities, Bike Haul Tickets and Bike Haul Passes

1. Big Sky Resort lift tickets and passes, Mountain Sports School lessons, equipment rentals, activities, bike haul tickets and bike haul passes are **non-refundable and non-transferable**. However, if the following qualifications are met, we will provide E-Vouchers for canceled products that can be used towards another online purchase at [shop.bigskyresort.com](https://shop.bigskyresort.com).
  - a. **For Winter 24/25 Lift Tickets, Mountain Sports Lessons, Rentals Activities and Summer 2024 Bike Haul tickets:** Requests for an E-Voucher must be made 48 hours prior to the product's start date and will not require any supporting documentation. Requests made within 48 hours will be ineligible unless appropriate supporting documentation of an injury is provided. E-Vouchers for the listed products will be valid through 5/1/2026.
  - b. **For 24/25 Winter Season Passes:** Requests made prior to the start of the winter, 11/27/24, will be provided an E-Voucher that will be valid through 12/1/25. Requests made after 11/27/24 will require supporting documentation of an injury that prevented skiing during the season. No requests will be accepted after 3/31/2025. If a pass is used, the formula to be used is: **Pass Price minus (Number of days used multiplied by the window rate on the date of use) = E-Voucher total.**
  - c. **For 2024 Summer Bike Haul Passes:** Requests made prior to the start of the summer, 6/8/24, will be will be provided an E-Voucher that will be valid through 12/1/25. Requests made after 6/8/24 will require supporting documentation of an injury to be provided. No requests will be accepted after 8/31/2024. If a pass is used, the formula to be used is: **Pass Price minus (Number of days used multiplied by the window rate on the date of use) = E-Voucher total.**
2. **M-BAR-T Pass Holder Specifics:** Big Sky Resort does not encourage nor condone students to miss class to utilize their M-BAR-T season pass. Big Sky Resort reserves the right to contact school administrators and parents/guardians when students are on the mountain during scheduled school days and may deactivate passes at its sole discretion.
3. **Season Pass Holder Regulations:** Individuals who misuse pass privileges by allowing their pass to be used by others invalidate the pass and are committing a crime punishable under Mont. Code Ann. § 45-6-305. Individuals that misuse their pass, operate recklessly, ski out-of-bounds or in an otherwise unsafe or inappropriate manner shall be subject to pass revocation without refund and in some cases may be subject to criminal charges under Montana Law. Those having misused Resort privileges will not be eligible for a season pass during this or future seasons.
4. **Season Pass Photo Requirements:** Season Pass purchasers agree to add a photo to their account for their pass and the Mountain Services Database.
5. **Lost or Stolen Season RFID cards:** Lost or stolen cards must be reported to the Mountain Services office immediately by calling 1-800-548-4486 or email [mountainservices@bigskyresort.com](mailto:mountainservices@bigskyresort.com). Replacement cards will be available for purchase at the Mountain Services office.
6. **KNOW AND OBSERVE 'YOUR RESPONSIBILITY CODE'**

Winter sports involve risk of serious injury and death. Your knowledge, decisions and actions contribute to your safety and that of others. If you need help understanding the Code, please ask any ski area employee.

  1. Always stay in control. You must be able to stop or avoid people or objects.
  2. People ahead or downhill of you have the right-of-way. You must avoid them.
  3. Stop only where you are visible from above and do not restrict traffic.
  4. Look uphill and avoid others before starting downhill or entering a trail.
  5. You must prevent runaway equipment.
  6. Read and obey all signs, warnings and hazard markings.
  7. Keep off closed trails and out of closed areas.
  8. You must know how and be able to load, ride and unload lifts safely. If you need assistance, ask the lift attendant.
  9. Do not use lifts or terrain when impaired by alcohol or drugs.
  10. If you are involved in a collision or incident, share your contact information with each other and a ski area employee.
